# Regarding the Application for the FY 2023 School Expenses Support

The "School Expenses Support" is a system that provides support for school supplies, lunch fee, and other school expenses for children who have difficulty attending public elementary and junior high school due to household economic reasons.

For those who wish to apply for "School Expenses Support" please submit the application form after attaching the required documents according to the following procedure. If you are receiving support for FY 2022 please make sure to re-apply to receive continued assistance for FY 2023.

# 1 Those that becomes an object of the support

Those who meet all of the following conditions are eligible.

- 1. Parents of children and students who have an address in Minokamo City and are enrolled in a municipal elementary or junior high school (The Tomika-cho Board of Education will provides support for children attending Futaba Junior High School.)
- 2. Households that meet one of the recognition standards for school expenses support in Minokamo City. (Recognition standards are as follows:)
